POWER OF ATTORNEY (FORM P-22)

You have the option of electing any one of the following National Service Organizations to give you advice and assistance in connection with claims and benefits handled by the Veterans Administration, such as pension, insurance, hospitalization and vocational rehabilitation. According to Public Law No. 844, 74th Congress, the following National Service Organizations, which have representatives in the offices of the Veterans Administration are authorized to perform this service.

It is not essential for a successful application that you enlist the aid of these organizations nor do you jeopardize your claim by not having their aid.

You may elect the organization of your choice by filling out the power of attorney (Form P-22) which is available in the Red Cross offices.
